Revise & Resubmit

The Three R’s of Commitment: Ratification, Reservation, and Rejection (with Willow Kreutzer): We argue and find that states ratifying CEDAW with reservations are less likely to see improvements in women’s rights than states ratifying CEDAW without reservations. We also show that states with worse women’s rights place reservations on articles most central to the treaty’s success.

Do Birds of a Feather Deter Better? Cultural Affinity and Alliance Deterrence (with Saera Lee and Addison Huygens): Research note that shows that military alliances with greater cultural affinity (latent measure) better deter severe attacks on member states, although conflict at lower levels is possible.

Under Review

Patterns of Government Disaster Policy Response in Peru (with Elise Pizzi): Applies coding scheme developed by our lab to capture disaster policy responses in Peru (e.g., relocation, reconstruction, restrictions on movements/outside aid).

Cross-Border Troubles? Interstate River Conflicts and Intrastate Violence: Examines how river conflicts between countries influences the chances for intrastate violence by exacerbating group inequities in water supplies and displacing populations.

The Issue Correlates of War (ICOW) Identity Claims Dataset, 1946-2021 (with Krista Wiegand, Paul Hensel, and Andrew Owsiak): Describes the new dataset and presents spatial/temporal patterns.

How Climate Volatility Impacts Human Rights in the Civil War Context (with Nathan Timbs): Estimates a PVAR model on a dataset of 194 countries from 1946-2017 and shows that increased weather volatility significantly reduces human rights protections for multiple years, especially in the civil war context.

Work in Progress

Interstate Identity Claims under the Territorial Integrity Norm (with Paul Hensel, Christopher Macauley, Krista Wiegand, and Andrew Owsiak): Using ICOW identity claim data, we study how territorial integrity norms have altered identity claims. We show that countries shift away from supporting ethnic kin’s secessionist claims towards support of policies that protect ethnic kin’s rights in neighboring states.

Paths to Peace in Issue Rivalries (with Bomi Lee and Cody J. Schmidt): Examines how issue rivalry networks influence peaceful and militarized conflict management in diplomatic issue conflicts; we find that rivalry networks constrain militarization by target states in issue claims but have no effect on challengers (revisionist states).

Issue Linkage of Territorial and Identity Claims (with Krista Wiegand, Paul Hensel, and Andrew Owsiak): Develops a theory of issue linkage connecting territorial and identity claims and evaluates the argument using ICOW data.

Water Wars? Conflict and Cooperation over Cross Border Rivers and Maritime Areas: This book project examines how countries handle diplomatic claims to fresh water and maritime resources and how water issues influence states' internal and external security risks.
