Activities During Academic Year 2007-2008

The Public Policy Center updated its mission in July 2007:

To provide policymakers with information that can make our lives and communities thrive in sustainable ways through academic research.

The 2007-08 academic year was a very productive one for the faculty, staff and students of the PPC

- 23 grants through the Public Policy Center totaling \$18,557,209. In addition:
 - \$5,730,714 is pending allocation and soon to be awarded

A grant totaling **\$56 million** submitted in collaboration with 3 state agencies regarding the re-entry into the community of mentally ill prisoners has receive preliminary acceptance One RO3 grant, jointly submitted with the University of Washington, is under review
